National Update

- The ACEP Leadership & Advocacy Conference was held July 25-27. Advocacy topics this year were as follows:
 - <u>Dr. Lorna Breen Healthcare Provider Protection Act</u>, which supports research into barriers for healthcare providers in seeking mental health treatment and has since unanimously passed the Senate
 - Mainstreaming Addiction Treatment Act, which would remove the X-waiver requirement for prescription of buprenorphine
 - Requested that necessary action be taken before the end of 2021 to ameliorate the scheduled Medicare payment cuts (sequestration plus budget neutrality, totaling nearly 10%)
- ED workforce concerns continue to dominate discussions on the national stage. No concrete decisions or changes have been made.
- ACEP Scientific Assembly will be held in Boston October 25-28 with both live and virtual options.

State Update

 We continue to monitor for downcoding by insurers especially that based on final diagnosis and that which is automated without a chart review. This has been an issue in other states and has been opposed by physician groups with variable success. Please let us know if you encounter this issue.

- Nursing staffing shortages continue statewide.
- With the rise of delta variant and increasing COVID cases, please stay engaged with your fellow DEACEP members to exchanges strategies and ideas.

This comes on the heels of hundreds of ACEP members joining together to lobby for this legislation during last month's Leadership & Advocacy Conference, conducting 287 meetings with legislators and staff from 44 states.
